Tis the season of Thanksgiving! A special time to pause and think of the many benefits God has bestowed upon us during the year. We usually thank God for our bounteous harvest of food and shelter. And we thank God for family and friends so dear to us. If we work at it a little, we can usually come up with quite a list of things to be thankful for.

But what about those times in the lives of each of us when there seems to be little, if anything, for which to be thankful? An untimely death; personal suffering and pain; loneliness, fear, or anxiety; an overwhelming sense that the world is out to destroy us. At those times, how is it possible to come to God with grateful hearts?

When I think on this question, I cannot help but think of Martin Rinkart, whose paean of praise, "Now Thank We All Our God," is sung in thousands of churches. He penned this hymn during an epidemic in which the number of the dead was so great that

they had to be buried in trenches. His own wife was taken; he lost his property and was driven to desperate extremes in finding food and clothes for his children. Yet, somehow, he could write these words for his hymn:

"Now thank we all our God with heart and hands and voices,

Who wondrous things hath done, in whom the world rejoices;

Who, from our mothers' arms, hath blessed us on our way

With countless gifts of love, and still is ours today.

O may this bounteous God through all our life be

With ever joyful hearts and blessed peace to cheer us;

And keep us in His grace, and guide us when perplexed,

And free us from all ills in this world and the next.

Rinkart knew that even in

the depths of sorrow and despair, God is present ready to give us strength and courage in times of

unbearable anguish. If we, too, will open ourselves to

God's presence and care for us, then thanksgiving does indeed become possible at

those times when there seems little to be thankful for because, if nothing else,

we can and should be thankful for God's gift of

God's self in our lives. Thanks be to God!

Presbytery welcomes three new minister members

Board of Pensions News: The Board of Pensions continues to work hard to protect our pastors, educators, and congregations in the midst of skyrocketing health care coverage. The good news is pastors who are retired or serving in less than 20 hours per week callings can now pick and choose what kinds of healthcare coverage would best fit their needs. Be sure to go to Pensions.org and “click around.”

Also, in the same vein, Commissioned Lay Pastors may now also negotiate with congregations to which they are commissioned for certain levels of coverage. Look for details at the Board of Pensions’ website – Pensions.org.

Please note the following changes in the amounts due starting January 1, 2021: Medical Coverage will increase to 27.5% of the effective salary. Pension and disability will be reduced to 9.5%. There is no change to the total percentage of what is required from the Board of Pensions. It remains at 37%.

It is our joy and privilege to welcome three new members to the Presbytery of Florida family:

Rev. (Margaret) Greta Reed (Honorably Retired) lives in Tallahassee and attends worship most frequently at First–Tallahassee. Greta comes to us by transfer from Greater Atlanta Presbytery and has already jumped into the work of the Presbytery. Most recently, she participated with the Racism Taskforce.

Greta served churches in South Florida and developed a nonprofit AIDS ministry before retiring in 2005 to the Atlanta area to write *Sacred Enticement: A Skeptic’s Journey to Faith*, a story she hoped would help other’s struggling with intellectual stumbling blocks to faith.

During her time in Atlanta she served on the Committee on Ministry's Pastor-to-pastor team, providing pastoral care to pastors.

Since moving to Tallahassee, she has worked with residents at Westminster Oaks living with dementia. She started a ministry called, Sparklers which is dedicated to recruiting, training, placing, and resourcing resident volunteers who would become a buddy to someone living with dementia.

Rev. Margaret O. Fox has accepted the call from First Presbyterian Church of Tallahassee as of November 1. She earned a Juris Doctor and Master of Divinity from Yale Law School/Yale Divinity School in 2015. Transferring from Maumee Valley Presbytery in Ohio where she served First Presbyterian Church of Perrysburg, she looks forward to serving the congregation in Tallahassee.

Margaret is looking forward to opening the scripture with a community of people – complex, nuanced, beautiful, and broken people – and ask, who is God and what is God calling us to do?



Rev. Mathew B. Frease accepted the call to be the Presbyterian Campus Minister at Florida State University Ukirk in Tallahassee. We had the privilege of hearing Matt preach at the October meeting of Presbytery.

Matt has said his sense of call has been dynamic and evolving; moving from a call to youth ministry as a youth director to perusing theological education at Columbia Theological Seminary (MDiv) to pursue ordained ministry. After doing work in Clinical Pastoral Education (CPE) he was led back to the academy at the Candler School of Theology at Emory University (ThM) and later Columbia Theological Seminary (currently a ThD candidate) to peruse deeper training and education in Pastoral Theology. He understands this evolving sense of call to be the Spirit's

mischievousness moving him to where his gifts and talents can be used to meet the needs people at unique and specific times in their lives.


