These are for deaths from October 1, 2021 to September 30, 2022. They will be included in the necrology report at the October 25 presbytery meeting. ► Attention, East District Clerks of Session and Pastors:

On Sunday, October 16, Christ Presbyterian, Tallahassee will host the meeting to read session minutes. The meeting will begin at 1:30 p.m. EDT in the Koinonia Room at the church, located at 2317 Bannerman Road, Tallahassee.

This will be to read and approve the minutes for 2019, 2020, and 2021. If you have older minutes that also have not been read, bring them, too. We are behind since we weren't able to schedule this annual review during Covid.

What to do to prepare for the meeting:

1. Print the session record review form, found on the presbytery website at <http://www.presbyteryofflorida.net/app/>

download/7126502598/Session+minutes+review+checklist+2021-04.pdf

2. Complete the form for each year (one form per year)

a. If you previously completed a form at the time you closed out your minutes, just use that form!

b. If you did not complete a previous form, use the current one for each year

3. Complete the information for each item in each of the SIX sections by either filling in the answer or circling yes/no (except for those items noted to be completed by READER)

4. Note the items on the last page that should be brought with you to the meeting

5. Completing the form ahead of time simplifies the review process. The reader only has to verify the answers and give a general review of the minutes.

Upon arrival at the meeting, each person will sign in, indicating their name and the name of the congregation and the years of minutes being reviewed. Each person will be paired up with another person and will exchange your books to review. The one reviewing (READER) may have questions and will ask those. Once a review has completed the pair will read the next set of minutes. This continues

until all the minutes presented have been reviewed.

The Reader will then sign the form and indicate if the minutes were approved without exception or with exception. If with exception, the reason must be listed. Those items would include:

- incomplete minutes (e.g., no indication of quorum present, lack of approval of previous minutes, absent members not listed, etc.
- OR
- missing required items (e.g., Sexual Misconduct Policy, Child Protection Policy, minutes in accordance with the Book of Order G-3.0204 Minutes and Records)

I find it helpful to also provide suggestions for improvement, if you see those. However, those should not result in an exception.

It is helpful for the clerk to present the minutes and assist with the reading. However, if you cannot attend on this date, please arrange for another elder (or the minister) to attend. It is vital that we have someone from each congregation present.

Please let me know by email or by phone (850-591-6284) if you are attending or sending someone else.

CMO shares array of impactful Presbyterian church projects

The committee on Mission and Outreach seeks to connect local congregations across the Presbytery for the purpose of enhancing and supporting each other as we seek to be the hands and feet of Christ in our local congregations and around the world. Since January of this year, we have been reaching out to the churches across the Presbytery and asking for information on the various service and mission projects you are providing.

Here is a summary of the impact of the 17 churches we have heard from. If your congregation is not listed, please complete the form [here](#), and we will include you in our next update! If you have trouble with the Google form, simply email susansbyram@gmail.com a summary of your mission projects and best contact person for outreach, as well as your Presbyterian Women's group contact.

Many of our congregations are called to support schools with children in high need. Lynn Haven, Gulf Beach (Panama City), Euchee Valley (DeFuniak Springs), Grace (Panama City), Faith (Tallahassee), First Destin and First Crestview all have ministries to help schools through a variety of

programs including food backpacks for the weekend, providing school supplies and supporting homeless students.

The most common way we reach out is through support of other organizations doing God's work. The following congregations support numerous charities from Habitat for Humanity to Blood Drives to Cancer Charities. If you want ideas on being involved with great charities in your community, contact one of these congregations: First Milton, First Tallahassee, Northminister, Faith (PC), Gulf Breeze, First Pensacola, Laurel Hill and First Monticello.

These churches support senior adults in need in various ways: Lynn Haven, First Tallahassee, First Pensacola and Grace. Grace and First Tallahassee also support the homeless. First Pensacola houses and runs a Resale shop.

Lots of our congregations house a food pantry or significant food program. If you need ideas related to this, contact one of these churches: First Quincy, Gulf Beach (Panama City Beach), Grace, Gulf Breeze, Faith, First Monticello or First Crestview.

Several churches

house community programs that make a difference. First Pensacola houses an Narcotics Anonymous program that meets 12 times each week, and First Chipley houses AA meetings. Grace houses Scout groups and a community choir.

Childcare is a huge need, especially these days, and at least three of our churches offer childcare centers. I am confident there are others, and networking with each other would provide a format for sharing concerns and ideas. Contact First Tallahassee, First Pensacola or Grace if you'd like more info on this. I hope the others who offer this ministry will let me know!

Finally, a few churches have outreach programs or partnerships overseas. Grace supports missionaries in South Sudan. Both Faith and Gulf Breeze have partnerships with Guatemala.

This month, CER interviewed John Guthrie at First Presbyterian of Tallahassee, who recently stepped down after years of leading the team for “The Inquirers” adult Sunday school class. It has 15-20 core members, which grew to over 50 attendees on Zoom. John joined the leadership with strengths in computer electronics, which put him in exactly the right place when Covid-19 hit.

Describe your Sunday school audience.

John: Urban mostly, younger and older, retired and working, professors and students, we are open to all “inquiring” adults with various interests and backgrounds.

What was your process for choosing and preparing topics/speakers?

John: We spend 8-16 hours per week on scanning theology and Bible study texts to topics of faith in *Presbyterian Today* and new books by leading theologians. Topics are all over the place, as we are a stone’s throw from the Capital. Many smaller classes do well with 2-3 hours of

preparation. The simplest source is to use the lectionary scripture passages for a more in-depth exploration of what the sermon will be on. Always there, always timely and reinforces worship.

How did you deal with electronics before, during, and after Covid?

John: Before Covid, we used overhead projectors and were able to play DVDs to show on a screen. During Covid, we increased our audio-visual equipment to show a wealth of online material on Bible study, stewardship, social justice issues like homelessness, poverty, environmental issues, and divisiveness of politics. Now, we use a hybrid way- (20 in-person/ 8-10 on Zoom) to include those living or on vacation far away, those vulnerable to illness young and elderly, shy, ride-challenged, and bed-bound.

John says, “Adult education is an exciting, personally rewarding ministry opportunity for teachers to learn and grow in their faith.”

CR spotlights Latinx and Hispanic Heritage Month

Latino-a and Hispanic Heritage Month is celebrated annually between September 15 and October 15. September 15 is crucial because it is the anniversary of independence for Latin American countries Costa Rica, El Salvador, Guatemala, Honduras, and Nicaragua. In addition, Mexico's Independence Day is September 16, and Chile's Independence Day is September 18.

The Lyndon Johnson administration was the first to observe Hispanic Heritage Week in 1968. President Ronald Reagan expanded it to cover 30 days.

The Hispanic/Latino community represents various cultures and nationalities and mixed cultures composed of people from South America, Central America, the Caribbean, Mexico, Spain, and other places. Hispanics/Latinos are the largest group of people of color in the United States and the third largest group of people of color in the Presbyterian Church (U.S.A.)

"As many of you as were baptized into Christ have clothed yourselves with Christ. There is no longer Jew or Greek,



there is no longer slave or free, there is no longer male and female; for all of you are one in Christ Jesus. And if you belong to Christ, then you are Abraham's offspring, heirs according to the promise" (Galatians 3:27-29).

The inclusion of the Latinx and Hispanic community in representative of the unity of believers in Christ as reflected in the diversity of our presbytery. In Christ, God unites persons through baptism, regardless of race/ethnicity by the power of the Spirit. Therefore, there is no place in the life of the Church for discrimination against any person. Hispanic/Latino-a people are involved in worship and evangelism and are equal partners in ministry and mission.

It is with gratitude that we share in the celebration of Latinx and Hispanic Heritage Month.

The Committee on Representation, in conjunction with the Committee on Nominations, will host the education hour at the October 25 presbytery meeting. The education hour aims to generate awareness about the work of the Presbytery and broaden our vision concerning inclusive participation.

The Inflation Reduction Act: a gift to Creation and the Least of These

The Inflation Reduction Act (IRA) will invest \$369 billion in climate solutions and environmental justice. **This is the single most important action this country has ever taken to address the climate crisis and help alleviate the unequal pollution and climate burden on the “least of these”.**

It does so much for so many, there isn't enough space here to even just list it. But here is a brief list and some resources if you want to learn more.

Big wins in this bill:

- ▶ Invests large amounts in clean energy and solar
- ▶ Reduces carbon emissions by up to 40%
- ▶ Provides for consumer incentives (tax credits and rebates) for solar, batteries, electric vehicles (EVs), energy efficiency and electrification
- ▶ Creates millions of jobs and help protects health, preventing up to 3,900 premature deaths each year

Wins for you:

- ▶ Projected average family savings if you take advantage of incentives of over \$1,000 per year.
- Tax credits for EVs: New ones up to \$7,500 and used \$4,000
- ▶ Rebates for home efficiency upgrades and electrification (removing gas)
- ▶ Rebates for heating

heat pumps and electrical panelboards, branch circuits and feeders

Wins for the “least of these”:

- ▶ \$3 billion in environmental and climate justice block grants
- ▶ Business incentives for solar projects for disadvantaged communities
- ▶ Funding and loans for rural renewable electrification
- \$315.5 million for air monitoring in low income communities

Wins for our communities:

- ▶ \$3 billion for U.S. Postal Service to electrify its fleet
- ▶ \$1 billion for clean school and transit buses, garbage trucks and other heavy-duty vehicles, prioritizing communities overburdened by air pollution.
- ▶ \$3 billion to clean up air pollution at ports by installing zero emissions equipment and technology
- ▶ Grants to help state and local governments adopt the latest building energy codes, which will save homeowners on their utility bills
- ▶ More than \$20 billion to help farmers and ranchers shift to sustainable practices like crop rotation and cover crops
- ▶ \$50 million to protect mature and old-

growth forests

- ▶ \$2.6 billion in coastal resilience grants to protect and restore coastal communities and ecosystems

Wins for our churches:

- ▶ Allows for tax-exempt organizations to take advantage of the 30% solar tax credit via Direct Pay. This provision doesn't begin until January 1, 2023
- ▶ Makes available block grants for community-based nonprofits (churches?) addressing [communities disproportionately impacted by climate change](#).
- ▶ Over time should lower church utility bills as renewable energy is implemented

This is the breakthrough we have been waiting for. This bill does an enormous amount of good for God's creation and especially for the “least of these”. I hope you are inspired to learn more and to take advantage of the incentives to reduce your home, business, or church energy use and to help low income communities.
