s we all know,
New Year's
Day is a time to
make resolutions to
improve ourselves in
some way. We say things
like we want to lose 10
pounds or start exercising
more. Some are able to
follow through with
their resolutions and
some, well, will be
making the same
resolutions next year!

In a way, our presbytery has made some New Year's resolutions. and we are already on our way to keeping them. As you are probably aware. the presbytery voted to cut the budget for 2024 by some \$130,000, reorganize the presbytery committee structure, make the General Presbyter position part-time, and work with the Dogwood Acres Committee to investigate what it would mean for the camp and conference center to

become a 501c3, bringing a recommendation to the October 2024 meeting of presbytery.

Here's where things stand on each one of those projects:

- 1. Churches are now in the process of making their pledge to the presbytery for 2024. The hope is to have heard from all the churches by mid-January to know what our actual budget can be. Since. going forward, 99.9% of the budget will need to be supported by our member congregations, it is crucial to hear from each congregation what their pledge will be as soon as possible.
- 2. An implementation
 Task Force has now been appointed by the
 Coordinating and
 Planning Commission and has been trained to begin their work January 1 in putting the presbytery's

decision regarding presbytery structure into place.



3. As part of their work, they will begin the

process of securing a part-time General Presbyter. This one may take some time, so they will start working on this immediately.

4. The Coordinating and Planning Commission is in the process of putting together a group of presbyters to work with the Dogwood Acres Committee on the 501c3 issue, and their work together should begin very soon.

I have been thrilled with the willingness of everyone to begin work on all these issues. I have already witnessed a huge level of trust among those tasked to fulfill presbytery's decisions, and I have confidence that these New Year's resolutions will be kept!

Resources available for fulfilling Book of Order policies mandates

ork continues at the General Assembly level to share sample policies for child protection and sexual misconduct, harassment, and antiracism as mandated by the Book of Order. The denomination offers a page that provides helpful information, including a PDF slideshow presentation on creating child-youth-protection policies.

Many congregations ask why they need a child-youth protection policy when they have no youth in their congregation. You need this to protect any child/youth, (grandchildren, neighbors, scouts, etc.) who may visit on occasion.

► The Annual Congregation Statistics opened Friday, December 1, 2023 and will close for congregations on February 16, 2024. THANK YOU to the two congregations who have already submitted their reports (Yes, I sent them gold stars).

The questions are the same as last year. I would suggest you take your form from last year and update from those numbers. You should have printed a copy of the stats to include in your minutes for the year. If you need a copy of your form, email a request to me. The program includes help on



the questions. To get to that information once you log in to the statistics program (Go to the Online Statistics Entry system), the tabs are "Church" (update church address information), "Clerk" (update the name of the clerk of session), and "Statistics". That last tab has a set of tasks in a box on the right side of the screen listing each category of questions (membership, congregational life, racial/ ethnic, financial). Each of those will give detailed instructions on completing those auestions.

Click "Submit" when you have finished entering all statistics and the session has approved this. The system will save each set of questions as you move through them. Once you submit, you indicate no further changes are needed.

PLEASE NOTE: The session needs to approve the report as early as possible after December 31, 2023. This is a session report and DOES NOT require approval at a congregational meeting. If you spend

more than five minutes on a question, put it aside and <u>contact me for</u> assistance.

A workshop will be held via Zoom January 18 at 6:00 pm Central/7:00 pm Eastern for any who have questions or need assistance. Watch for information in the Presbytery's weekly eUpdate, or email me for registration.

► And finally, we need to plan how to get the 2023 minutes read. Email me your answers to these questions: 1) Are your minutes saved in an electronic format (like Word or Google Docs)? 2) Do you know how to combine those individual files into one document (so all of the minutes for the year are in one file)? 3) Do you know how to print or save that single file to a PDF?

Please email your answers to me ASAP so we can determine if this would help facilitate the review. And be sure to notify the Presbytery office and me if there is a change in your clerk of session for 2024.

Panama City-Parkway has been moving forward in their strategic planning, exploring ways to reach out to the surrounding community in even better ways.


We also had several congregations take advantage of our Emergency Repairs Grant and Equipment Grant.



COP28 called Climate Change Super Bowl

or many of you, the Super Bowl game is the highlight of the football season and brings millions of people together. When the game is over, there is always a winner. The game brings joy to its watchers and something bordering on ecstasy to the fans of the winning team.

A reporter recently said that the December meeting of the COP28 was the Super Bowl of meetings on the climate crisis. In case you are wondering, "COP" stands for "Conference of Parties", and the 28 refers to the 28th meeting of this group of 200 world leaders. It was formed by the United Nations Environmental Program at the 1992 Earth Summit in Rio. It brings nations together to find climate crisis solutions and. because of this, we are making progress, but nowhere near the progress needed.

This year, the United Arab Emirate hosted the meeting, and Sultan Ahmed Al-Jaber was appointed COP president He also is the head of the UAE state-owned fossil fuel company, so even before this meeting began, it was controversial. The meeting also had about 2400 well-funded fossil fuel lobbyists present. That meant that about one out of every 40 attendees opposed phasing out fossil fuels.

There also were

hundreds of delegations representing the medical community, businesses, youth, island nations, indigenous people, faith groups and more. As in the past, the PCUSA sent a delegation.

"Phase Out Fossil Fuels" was the rallying cry for climate justice advocates, but the COP agreement's first draft failed to call for a phase-out and prompted an outcry from climate-vulnerable countries and others. They demanded stronger language reflecting the true urgency of tackling the climate crisis.

COP28 final agreement highlights included:

- Language to "transition away" from fossil fuels
- A call to phase down the "unabated" use of coal
- •A request to triple the global renewable energy capacity by 2030, and
- Creation of a climate disaster "loss and damage fund"

The agreement, disappointingly, did not call for a "phase out of fossil fuels," which 130 countries supported. Unfortunately, the "transitioning away" language it included is ambiguous. Dr, Friederike Otto, a climatologist at Imperial College London, said: "Until fossil fuels are phased out, the world will continue to become a more dangerous,

more expensive and more uncertain place to live. With every vague verb, every empty promise in the final text, millions more people will enter the frontline of climate change and many will die."

So, this climate Super Bowl wasn't the win the world needs, but it conveyed a clear message for the church. When the majority of world leaders say it is time to "phase out of fossil fuels", and they all say it is time to "transition away from fossil fuels", it is time for the denomination to stop supporting the fossil fuel industry with our investments. This is what thousands of Presbyterians have been asking of our denomination for nearly a decade and will once again ask at next summer's General Assembly.
